REGULATION TITLE AND NUMBER: Military Veterans and Active Duty (4.015)

SUMMARY: The University seeks to amend FAU Regulation 4.015, Military Veterans and Active Duty. The purpose of this amendment is to reflect compliance with recent amendments to

- 1. Changes the definition of student for the purposes of the regulation to any eligible student(s) who are or were members of the United States Armed Forces.
