## Florida Atlantic University

Regulation 1.002 Administrative Organization

(1)\_The principal officers of the University are:

(a) \_\_\_\_\_The President. The president is the chief executive officer of the University and is responsible for the operation and administration of the University. He/she is appointed by the Board of <u>Trustees</u>

(b) The University Provosand Vice President for Academic Affairs he University Provost shall be responsible to the President for the administration of the academic affairs of the University and shall perform such other duties as the President may designate.

(c) The Vice Preislent for <u>Financial Affairs</u>. The Vice President for <u>Financial Affairs</u> shall be responsible to the President for the administration of the University's business affairs and for campus security at the University, and shall perform such other duties as the President may designate.

(d) \_\_\_\_The Vice President fcr <u>Community Engagemen</u>The Vice President for <u>Community Engagemen</u>sthall be responsible to the President for the administration of the AlurAssociation Media and Governmental <u>Relations, Advancement Services</u>,

and the Florida Atlantic University Foundation, to encourage advocacy and support of the Unitvertisity its various constituencies, the general public and the media and to perform such other duties as the President may designate.

(e) \_\_\_\_The Vice President for Student Affairs. The Vice President for Student Affairs shall be responsible to the President for the administration of the University's student affairs and shall perform such other duties as the President may designate.

(f) \_\_\_Other Administrative Officers. The President may appoint, subject to the rules and regulations of the Board of <u>Governors</u> such other administrative officers as he/she deems necessary with assignment of duties in the interest of the University.

(2)\_The academic programs of the University shall be administered by the Colleges. Creation of a new College shall require study and recommendation by the University <u>Faculty</u> <u>Senateand approval by the President</u> the Board of <u>Trustees, and,sappropriate, the</u> <u>Board of Governor</u>sThe President grants degrees on the recommendation of the faculties of the several Colleges. The Deans of the several Colleges shall administer the academic and budgetary policies of the Colleges and are responsible the University Provost

(3)\_Academic units such as the Libraand Institutes\_

shall be administered by the <u>University Provos</u>tunless otherwise specified by the President.

(4)\_OrganizationalChart. The graphic description of lines of authority on file in the President's office shall be the organization of the University until changed by the President as prescribed by these <u>regulations</u>
