NOTICE OF PROPOSED REGULATION AMENDMENTS**

Date: July 6, 2012

**REGULATION TITLE AND NUMBER:** Approval and Execution of Contracts (6.002).

**SUMMARY:** FAU Regulation 6.002 addresses authority for the approval and execution of University contracts. The proposed amendments update the regulation to reflect current applicable governing authorizations for such purposes. This regulation amendment shall be effective August 6, 2012.

**Regulation 6.002 Approval and Execution of Contracts.**

(1) The President of the University may approve and execute contracts on behalf of the University ~~as provided in Section 1001.75, F.S. and~~ in accordance with the Board of Trustees Policies and Procedures or as otherwise delegated by the Board of ~~Regents~~ Trustees.

(2) No person, except as provided elsewhere by rule, regulation or Board of Trustees Policies and Procedures, or as otherwise delegated by the President, is authorized to enter into any agreement which purports to bind the University.
